He states that because of this, it is imperative that those accused seek legal representation immediately and that this representation should come from an attorney with experience in handling DWI cases. Butler says that because these penalties are so severe, those accused of a DUI should contact his firm immediately after being stopped to ensure that immediate action can be taken to potentially overturn those charges.
