Meanwhile, Chapter 11 bankruptcy is for small businesses, allowing them to restructure and reorganize debts while continuing to operate. The businesses are permitted to develop their own payment plans, as long as the plan is approved by the bankruptcy court. Chapter 13 bankruptcy allows the debtor to pay the debts back slowly for a number of years. People who are in debt but have a consistent income will usually go for a Chapter 13 bankruptcy.

The law firm is also capable of handling the various areas of domestic law, including divorce, separation, and child custody. 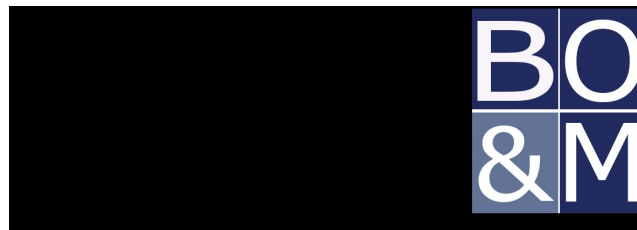
