All of our equipment is new. Our chairs are only used for our beach bonfire setups. This means the chairs are clean and new - not banged up, faded, and covered in suntan lotion."

Bonfires on the beach are a tradition that residents and vacationers have been enjoying for many years. The main problem that vacationers have is not knowing where bonfires are permitted or what needs to be acquired before bonfires can be built. Special permits must be obtained in order to legally have a fire pit on the beach. Vickers says that the company obtains these permits and provides everything else that is needed to make the fire pit legal, so that the company?s customers can just sit back and enjoy their bonfire. Those visiting Florida beaches have also found that bonfire setup can be expensive, due to the fees paid out to third parties for booking. Vickers says that their packages range from the basic, which includes Smores supplies and firepit setup and take down to their more comprehensive package, which includes four hours of firewood, firepit setup and clean up, legal county permit, Smores, roasting sticks, face and hand wipes, table with linens, Nautica chairs and a small cooler with ice and water bottles.

Bonfires on the Beach services all of the beaches along 30A including Miramar Beach and Destin, as well as Santa Rosa Beach, Crystal Beach, Rosemary Beach, Panama City Beach, Seagrove and many others. Vickers states that all beach bonfire setup must be booked over the telephone, to allow the owners to cover all of the necessary details of the bonfires.
