Among the local dignitaries attending were the city's Mayor, Fire Chief, and Supervisor of Elections. The Escambia County Sheriff and Pensacola Naval Air Station's Commanding Officer were also in attendance. It's a tradition for these people to "surrender the city" to the acting Don Tristan de Luna and his Queen for the 10-day period that the Fiesta runs.
