According to the firm, "Dangerous chemicals can pose a high risk of sustaining severe burns. A chemical burn occurs when the skin becomes exposed to certain corrosive substances which include the oxidizing acids contained in cleansers, from hydrocarbon solvents, and alkalis like ammonia and sodium hydroxide. Chemical burns frequently cause serious pain and suffering and extensive tissue damage. How severe a chemical burn is will depend on several different factors, which include how long the skin was in contact with the chemical, the concentration of the dangerous agent contained in the solution, and the extent of the penetration of the harmful chemical."

Many factors can lead to the sort of situation that exposes a person to chemical burns. For instance, victims may unwittingly use defective/dangerous products or tools (issued by their employer), find themselves in motor vehicle accidents (particularly if the chemical in question is being transported), and so on. There are even cases of chemical burns caused by medical malpractice. Whatever the case may be, victims are advised to seek an experienced personal injury lawyer as soon as their health issues are stabilized. The firm is willing to see family members or other representatives on the victim's behalf if the latter is unable to visit in person due to the extent of their injuries.

Notably, the firm cautions that chemical burn victims should prioritize their own health as soon as they are

hurt. Burns caused by heat and fire are known to be dangerous, but burns caused by certain chemicals can pose significantly more threat to a person's life if left untreated for any period of time, even if the damage seems superficial at first glance.

A burn victim's first step must be to remove the chemical as quickly as possible. This can often be accomplished by showering for half an hour under a high powered jet; the firm strongly advises against fully immersing the wounded area in water. This is due to the fact that a stream of water can help wash away any remaining chemicals quicker. Above all, victims must promptly see a medical specialist in order to get the treatment they need.
