Tommy Spina, a former judge and current criminal defense lawyer addressed the justified concerns of the public. He defended the bail bonds system and bail bonds agents. He cited the Eighth Amendment of the Constitution, which guaranteed the right for an arrested citizen to be allowed bail.

that his amendment, ?has the opportunity to save lives and keep the most violent of offenders from using the

revolving door and getting right back out into the community.?
