Flutterwave connects the entirety of the African continent to the rest of the world by providing the easiest and most reliable payment solutions for businesses from all over the world. To date, the financial technology firm has processed over 107 million transactions, which value at over \$5.4 billion. Global leaders, such as Uber and Booking.com count themselves among the companies that make use of Flutterwave's transaction systems.

Mike Law, a representative for Sunsella, says, "As with any company in the industry today, Flutterwave wants to be more. They have done an excellent job as a payment technology company so far, and their experiences will have given them a unique insight into a number of other sectors, such as education, travel, gaming, e-commerce and more. The new round of investments means that Flutterwave will be able to provide more solutions around the broader needs of their clients.
