Dangerous chemicals in the workplace can expose workers to a high risk of suffering from severe burns. A chemical burn will occur when the skin is exposed to corrosive substances, including the oxidizing acids found in cleaners, from hydrocarbon solvents, and alkalis such as sodium hydroxide and ammonia. Chemical burns are often very painful and can cause severe suffering and serious tissue damage. The severity of the chemical burn will depend on a number of factors, including how long the skin was in contact with the chemical, the extent of the penetration of the chemical, and the concentration of the corrosive chemical in the solution. able to get compensation for their losses. The amount of compensation will depend on a number of factors.

These include the victim?s pain and suffering, medical care costs, lost wages, and punitive damages.

According to personal injury laws, victims are eligible for compensation for the physical and emotional pain
