The Duluth car accident chiropractor advises victims to receive necessary medical treatment immediately after a collision. Highlighting the importance of a timely diagnosis, Dr. Gentry advises car accident victims to stop and check for injuries, adding, ?Leaving the scene of an accident can be considered a felony.?

Sometimes the rush of adrenaline makes one feel fine immediately after a crash, which might hide the pain for some time until the adrenaline wears off. The car accident doctor in Duluth, GA, suggests calling 911 after a motor vehicle collision in case of any pain in the back, neck, legs, shoulders, and other areas.

Calling the police is another important step a victim of an auto accident must take. The accident chiropractor emphasizes the need to document the exact circumstances of the crash, which becomes a vital piece of information in a personal injury claim.

Another serious mistake that most victims make, says Dr. Gentry, is to forget to exchange information with the other driver. The Georgia chiropractor explains the type of details a car accident victim should exchange with the other driver before leaving the accident scene. Both parties should cooperate and exchange details. ?If the other party doesn't cooperate, this information should be on the police report.?

Additionally, the Duluth auto accident chiropractor suggests getting contact details from eyewitnesses to verify the accident. It is equally important to notify the victim?s insurance company about the accident. The Duluth, GA, car accident chiropractor explains that the insurance company needs details of the accident to determine who was at fault, how one's rates will be affected, and what claim the victim can file for vehicle damage.

Dr. Gentry cautions against waiting to seek medical treatment after an accident, adding, ?Be aware of the statute of limitations of a claim with your insurance in Georgia. If you wait too long, you might not be eligible for compensation.?

Some car accident victims tend to refuse medical care, says the Duluth chiropractor, advising, ?No matter how you feel after a car accident in Duluth, you should always see a medical professional.?
