Due to the government's lack of resources and holding defrauders responsible, the government must rely on individual healthcare workers in the market to come forward with info so they can hold those who defraud the program liable.

"Fraud against the Medicare program may take many forms," said the Louisiana healthcare whistleblower lawyer "The Fraud can include adjusting patient records to get paid more from Medicare, overcharging the government, providing subpar healthcare services, or products, and many other things. The government relies on private whistleblowers to come forward with direct knowledge and proof of dishonest activities and the government rewards them for their vital support. Through qui tam suits, whistleblowers are able to bring civil claims against those parties on behalf of the federal government under the False Claims Act and can be rewarded for it."

The federal False Claims Act is a federal statute that renders it illegal for anybody to make incorrect Medicare claims or otherwise defraud the federal government. It additionally makes it possible for a healthcare worker with knowledge of fraudulent activity against the Medicare program to file a whistleblower legal action on behalf of the government. In exchange for their info and effort, the whistleblowers may be entitled to collect incentives of between 15 and 30 percent of the money by the government. The act also has stipulations for whistleblower shield against any company retribution which may result from submitting a suit or accepting work with the government.

When a whistleblower steps forward with relevant information concerning Medicare scams, the case is submitted in federal district court. It is put 'under seal' while the Department of Justice investigates the complaint and the proof speaks with witnesses and speaks with experts and company personnel. The government will then decide if it will step in. If the government does not, the whistleblower still may continue the case by themselves.

Due to the fact that health care employees place themselves at risk doing this important work, the federal False Claims Act highly incentivizes the potential whistleblowers with a significant portion of the financial recuperation. In an effective claim, the government can recuperate up to three times its losses to fraudulent activity in addition to charges for each event of fraud.
