The accident lawyer explains that head-on collisions are very dangerous because of the force of impact equal to their combined speed. That means that if both cars are running 30 miles per hour when they collide, the

force of impact will be 60 miles per hour. The lawyer further explains in the article that since the people inside are traveling at the same speed, they can suffer serious injuries.

New York Head-on collision lawyer Samantha Kucher also discusses in the article the most common reason for head-on collisions in New York is one driver driving on the wrong side of the road. Aside from that, common reasons for head-on car collisions include crossing the centerline, improper passing, taking curves too fast, distracted driving, and speeding.

The lawyer discusses the most common head-on collision injuries in the article, too. Attorney Samantha Kucher mentions that the most common head-on collision injuries include crushed extremities, spinal cord injuries, fractures, traumatic brain injuries, internal bleeding, amputation, paralysis, internal organ damage, orthopedic damages to the neck and back, and also wrongful death.

Attorney Samantha Kucher also says, "After a serious head-on collision, an injured victim may be looking at months, years, and even a lifetime of physical, emotional, and financial issues resulting from their injuries. Consequently, an injury victim can be entitled to monetary compensation from the at-fault party after a devastating head-on collision."

Aside from the aforementioned, the head-on collision lawyer also discusses that some insurance companies are often reluctant to pay valid claims for injuries that are caused by head-on collision accidents.
