Additionally, the personal injury lawyer mentions that New York is a no-fault insurance state. This means that if someone is involved in an accident, the victim can seek compensation from their own insurance first, no matter who is at fault for the accident.

Furthermore, the lawyer also adds that if the injuries sustained by the victim exceed the benefit limits, they may be able to file a claim or a lawsuit against the "at-fault" party. Even if the victim can be partly-at-fault, they may still be able to receive compensation for their damages.

Attorney Samantha Kucher explains that car accidents, most often than not, result in injuries. The most common injuries caused by these kinds of accidents include bruising and contusions, concussions and other traumatic brain injuries, internal bleeding, neck injuries, and even wrongful death.

Drunk driving and impaired driving are also other causes of car accidents. Some causes that are not the driver's fault also include vehicle malfunction and road hazards.
