Accident attorney Samantha Kucher mentions that according to the National Floor Safety Institute, falls are the leading cause of emergency visits in the United States. Falls constitute over 8 million hospital emergency room visits each year. Especially for older adults, falls are very dangerous.

In the article, attorney Kucher explains that slip and fall cases are protected under the premises liability laws in New York. Under the premises liability law, the person who owns or is in control of the property must keep the property safe for those who use it.

Additionally, the accident lawyer explains that if someone fails to keep their property safe, the victim may have the right to hold them responsible for their injuries. The victim may also ask for compensation for the medical costs, lost wages, personal property damages, lost earning capacity, pain, and suffering.
