The blog post blames driver error as a common cause of any type of accident, adding that driving a truck is a very demanding, stressful, and high-pressure job. Restlessness is another common cause of truck accidents, states The Mabra Firm, as many truck drivers drive for long hours with very little rest or no sleep at all. When a driver is tired, this results in slower reaction times and a loss of coordination and concentration. Driver fatigue is a prime culprit in many truck accidents.

No matter what a semi-truck is carrying, the products must be carefully packed and secured so that the weight is evenly distributed across the truck. The blog post explains that if the driver or their company fails to ensure even distribution of weight, it can lead to a horrible truck accident. Low-filled liquid loads are also a cause of truck accidents. The personal injury law firm in Atlanta explains that leaving a tank partially full can become extremely dangerous, as the liquid in the truck can splash around inside the tank, causing the truck to sway back and forth.
