car accidents.

between the vehicles. People inside a vehicle are traveling at the same speed as the vehicle. Head-on

collisions are dangerous because both the vehicle and its passengers decelerate upon impact. This can lead

to serious injuries and even fatalities, even if the vehicle has a safety restraint system.

?After the fault is established, the injured party must also establish injuries. New York has no-fault insurance

laws that allow injured parties to pursue compensation for medical bills, lost wages, and other expenses from

their own insurance company after an accident. In addition, those who are injured in a head-on collision can

pursue recovery from pain and suffer from those who caused their injuries. In order to do so, they must meet

what is known as Serious Injury Threshold,? says the accident lawyer.
