neglecting them. Neglect can also be caused by staff not being properly trained to care for elderly frail residents.

Attorney Samantha Kucher says that there are many types of nursing home neglect. This includes neglect of emotional and social well-being. This is when an elderly resident is isolated or separated from their peers. Residents in nursing homes must be allowed to communicate with one another.

In the article, the lawyer mentions that victims of neglect may show certain signs. These signs include sudden changes in mood, unexplained lacerations or bruises, and marks on the wrists or ankles.

According to the personal injury lawyer, "Unfortunately, it's not enough to take the victim's word about nursing home neglect happening to them as many nursing home residents suffer from cognitive decline due to dementia or Alzheimer's. Even those who don't have those conditions may not have been lucid enough to be able to explain what happened. As a result, the nursing home abuse lawyer must prove that certain elements are in place in the case."

Lastly, the lawyer emphasizes that it is important to seek the help of an experienced nursing home negligence attorney. A skilled lawyer may be able to guide the victim in seeking compensation for their injuries and also help them understand their legal rights, responsibilities, and options.
