The three largest credit reporting agencies in the country, TransUnion, Equifax, and Experian, have all stated

that certain types of medical bills will no longer be recorded on credit reports. Unfortunately, those whose medical debts exceed \$500 are not affected by this change. Regardless, the Biden-Harris administration is working hard to minimize the impact of medical debt on credit scores so that those who are in need can still access certain debt forgiveness programs and qualify for future loans, among other things.
