The top Atlanta accident injury treatment clinic advises victims not to take any missteps after an accident to improve their chances of getting the best outcome possible after the accident.

The blog post advises accident victims not to leave the scene of the accident as it is illegal in some states to do so, adding the importance of stopping the vehicle, pulling out of traffic to a side, and calling 911. The chiropractic clinic suggests calling emergency services in the event of an accident, including a minor fender bender because it is important for law enforcement to respond to the scene and write a police report with details of the accident. An accident report is crucial in establishing negligence in a case, which is vital for the personal injury claim.

Law enforcement will detail the events of the car accident, including the road conditions, names and contact information of witnesses, and an official write-up of how the accident occurred. An accident attorney uses the police report as part of their investigation.

Dr. Summer Turner, the leading Atlanta chiropractor, cautions victims of accidents against losing their cool, warning that a burst of anger with the other driver "will come back to bite you during the claims process." The blog post advises accident victims to stay cool and ask the other driver if they are okay and avoid blaming them for anything or yelling at them. A good frame of mind will help the victim of the accident assess any property damage and injuries and do what's needed to document the accident and gather information.

Another don't on the list is not to admit guilt for the accident, suggests Dr. Turner, adding that it could ruin the victim's chances of receiving compensation for economic and non-economic losses and expose them to a lawsuit or other penalties. "An apology is just as bad as admitting guilt. The other party and their personal injury attorney will use your words against you and will try to turn your apology into an admission of guilt. Many people don't realize how much what they say can negatively impact their case," advises the leading Atlanta car accident chiropractor.

Dr. Turner explains that a victim need not say much at the scene of the accident and let their personal injury attorney do most of the talking on their behalf. The top Atlanta car accident doctor suggests victims to be polite yet cautious if the other driver's insurance company tries to contact them after the accident. The blog post states that a victim should not reveal any piece of information to the other party or insurance adjuster and let them speak to their accident attorney to get the information they need.

Dr. Turner cautions victims not to accept a settlement too quickly, advising, "Don't give them a recorded statement, and don't sign anything, especially if you haven't consulted with your lawyer." The blog post states that accident victims should exchange contact information and insurance information with the other driver, including the name of their insurance company and their insurance policy numbers. Arrowhead Clinic explains the importance of documenting the car crash and gathering as much information about the accident as possible. This includes taking pictures of the accident scene, license plates, vehicles, and injuries.

The blog post even advises taking pictures of a traffic light that wasn't working and talking to eyewitnesses so they can write a short statement about what they saw and get their names and contact information. It is equally important to take note of the time and date of when the accident occurred and the weather conditions at that time. The information can play a crucial role in the accident injury settlement, states the blog post, without which it might be difficult to prove what actually happened.

Dr. Turner advises victims of accidents not to ignore medical help even if they feel fine. Besides, the best Atlanta car accident doctor suggests seeking legal help if another driver is at fault for the accident. In

addition, a victim of a car accident should start the insurance claim process with their insurance company as soon as possible and check what the insurance plan covers ahead of time.

Seeing an accident doctor is crucial to the accident claim as a doctor can document the injuries and treatment to protect the legal rights of the victim. Proper documentation will help ensure that the victim is fairly compensated without the need to go to a trial. The blog post advises accident victims to see a car accident doctor if they don't need emergency medical attention at the emergency room.
