According to the Brooklyn workers' compensation lawyer, ?If you?ve been injured on the job, there are two things you must do immediately. First, you need to obtain any necessary medical treatment for your injury. Next, you need to notify your supervisor or manager so they can report the injury to the New York Workers? Compensation Board, as well as your employer?s workers? compensation insurer.?

The lawyer mentions that the victim will have to file Form C-3 (Employee?s Claim for Compensation). They don?t have to do it right after the accident since they will have two years from the date of the accident. It can

also be two years from when a medication condition related to the accident is discovered.

Attorney Samantha Kucher adds that under New York Law, all employers are required to have worker's compensation insurance. This rule includes part-time employees and family members who are employed by the company. Employers have the option to choose an insurance carrier. They may also choose between self-insurance or using the New York State Insurance Fund as long as the mandated coverage is in place.

In the article, attorney Kucher says that some employers may encourage employees to not seek out an attorney. However, the choice is up to the victim. Victims of workplace accidents have the right to legal representation if they have been injured on the job. Hiring a New York City workers' compensation attorney may help ensure that they are receiving the compensation they deserve.

According to the workers' compensation lawyer, "Injured employees have the right to be compensated for the costs of medical treatment to date, expected future medical treatment including surgery, lost wages, future lost wages, and disability payments if applicable."

Lastly, the accident lawyer emphasizes the importance of having an experienced workers' compensation lawyer if someone has been a victim of a workplace accident. Having a skilled lawyer may be able to help the victim receive the compensation they deserve.
