However, it does not cover outpatient surgeries, doctor?s visits, lab work, preventive services, and ambulance services. These medical services, which are outside of inpatient hospital care, fall under Medicare Part B. Part B also covers cancer therapy and kidney dialysis. Some patients can also opt for Medicare Part C, which is a voluntary Medicare Advantage program. Finally, Medicare Part D covers retail

prescription drugs.

Though Medicare offers a large breadth of coverage, it passes quite a few costs on to patients. This includes expenses such as coinsurance, copayments, and deductibles. To ensure that patients are not left wanting essential coverage due to the gaps in their Medicare plans, private insurers have stepped in to offer Medicare Supplements or Medigap Plans. There are 10 standardized Medicare Supplement plans, each identified by a letter - Medigap Plan A, Plan B, Plan C, Plan D, Plan F, Plan G, Plan K, Plan L, Plan M, and Plan N.
