The lawyer explains that New Jersey law separates murder into three separate types. The first type is when

someone purposely caused the death of someone else. The second type is when the death of someone is knowingly caused by someone else. The last type is when someone causes the death of someone during the commission of a robbery, sexual assault, burglary, arson, and other felonies.

Attorney Adam M. Lustberg adds that if someone is not facing the death penalty in New Jersey, they will be exposed to a long period of time inside the state prison. A minimum of 30 years is mandated for murder before the defendant is eligible for parole. The maximum sentence is life.

?If the offense is against a law enforcement officer or against a child under the age of 14 who was killed during the commission of a sexual crime, the sentence can be increased to life without parole,? the lawyer says in the article.

Furthermore, attorney Lustberg adds that only a few lawyers are able to have the experience necessary to fight a murder charge. This is why it is very important for someone to hire a criminal defense lawyer wisely. The defendant will have to trust the lawyer with all they have and they would want to make sure that their lawyer is someone strong enough to give them an aggressive defense.
