Attorney Seth Schlessel says that Medicare and private insurance usually won't cover nursing home stays for long periods. While some families are able to cover the costs of nursing homes or invest in long-term insurance, other families will have to use Medicaid. This can mean that assets that were not transferred at

market value within the five preceding years may make the person ineligible for Medicaid.
