According to the Hackensack domestic violence attorney, "According to a recent report by The Center For Prosecutor Integrity, a national survey conducted by YouGov reported that 8 percent of Americans have been falsely accused of domestic violence or other forms of abuse. This figure represents about 20.4 million individuals in the United States."

The lawyer explains that someone can lose their future if they are accused of domestic abuse. Someone who is accused of domestic abuse can face jail time, lose their professional and personal reputation, or even lose

access to their children. An individual charged with domestic abuse should seek the advice of an experienced defense attorney.

Attorney Adam M. Lustberg adds that New Jersey state police define domestic violence as "a pattern of physical, emotional, verbal, and sexual abuse, which includes, but is not limited to, threats, intimidation, isolation, and/or financial control." It comes in four primary forms abuse including physical abuse, emotional abuse, sexual abuse, and financial abuse.

In the article, attorney Lustberg explains that domestic violence can refer to any act that involves the abuse, verbal, or emotional, of a partner, current or former. Domestic violence can usually be described as physical or sexual assault, harassment, and threats. However, there are other criminal offenses that can also be connected to domestic violence.

"While most people consider domestic violence to be actions of physical abuse, they can also include sexual, emotional, economic, psychological abuse, or threats of actions against the other party. Consequently, an individual can be charged with domestic abuse without even physically touching their victim," says the domestic violence lawyer.
