Possession of a rifle or shotgun without a firearms ID card can result in three to five years in prison. The minimum mandatory jail sentence applies to the unlawful possession of a handgun charge because it falls under the Graves Act.

Attorney Adam M. Lustberg adds that a person who has a prior conviction is not allowed to possess a firearm if they are found with one in their possession. This is referred to as a Certain Person offense and anyone who is convicted of this charge can face five to 10 years in prison and will not be eligible for parole for a minimum of five years.

In the article, attorney Lustberg adds, ?Possession of a firearm during the commission of these offenses is considered a second-degree offense. Furthermore, if there is an additional conviction for possession of a

firearm for an unlawful purpose, prison time must be served consecutively.?
