The Saorsa Swift system harnesses the unique properties of microwave radiation to offer plantar warts therapy that is faster, cleaner, and safer than conventional methods of treatment. Microwave radiation has been studied extensively for decades by the scientific community and its non-ionizing nature makes it particularly suited to medical applications. With the Saorsa Swift System, dermatologists, and podiatrists all over the nation now have a device that can conveniently capture this power and offer their patients a much better experience.

Cryotherapy, laser ablation, and salicylic acid, the conventional methods of addressing the foot condition, are imprecise as they also damage the healthy tissue surrounding plantar warts. Laser ablation and electrocautery treatments produce a plume that is hazardous to both the patient as well as everyone else working at the clinic. Microwaves generated by the Saorsa Swift system are highly localized, travel in straight

lines with no lateral spread, and the depth to which they penetrate the skin can be accurately controlled. So, Saorsa's microwave-based system only acts on the affected plantar warts, making for a cleaner treatment.

Patients report no or very low levels of pain during the procedure which saves costs on anesthesia. After the treatment is over, there is also no need for any post-procedural dressing or padding. Appointment times are also much shorter at just 5 to 10 minutes. This also allows clinicians to book more patients during the day and overall help more patients in their service area. Plantar warts can usually be effectively treated within 2 to 3 sessions with around a month between each successive appointment.
