It is also a great idea to consult with the insurance firm before starting any repairs. While most insurers will pay for the most significant damage, it is important to check with them first to find out if there are any things that can be patched up or repaired. It would also help to take photos of the damaged items so that these can be shown to the adjuster. And all receipts and lists of expenses should be made available for supporting the claim. It would be a great help to take photos or videos of the damages. With regards to the damaged roof, it would be a good idea to take photographs of it but not climb it.
