



Law Firm Reveals That A Workers Comp Lawyer Has Become Essential In Workers' Compensation Cases

The Riverside County Workers Compensation Lawyer has revealed that it has been becoming increasingly common for people to require a workers comp lawyer to handle cases against their employers. Indeed, a recent report has shown that there has been a 1.3% increase in benefits awarded to employees who had representation from a proper workers comp lawyer. On the other hand, the cost to employers as a result of this development has increased by 6.9%. This demonstrates that people are feeling more confident about seeking compensation where it is due.

"We believe that we are seeing more cases due to the improvement in the overall economy", says Kevin Cortright, workers compensation lawyer for Riverside County Injury Lawyer. "As the economic recovery continues, more people are finding work and more people are finding themselves in a situation where they require compensation."

Previous reports have shown that the benefits for every \$100 of covered payroll was lower between 2007 and 2012 than it has been at any time over the past thirty years. In 2012, the benefits of every \$100 of covered payroll were \$0.98. At the same time, the costs for employers were \$1.32 for every \$100.

"It is important to compare trends", added Kevin Cortright. "This is because when the costs and benefits of covered payroll are shared, we can clearly see that there are also employment and earnings changes. As a result, although it is not desirable for employers to have many claims made against them, it does show us that the economy is seeing strong and significant growth."

Interestingly, workers' compensation was the very first type of social insurance program in our country. It was first instated in 1912, so it is now 100 years old. It has not always covered every state, but at least 15 states have followed these laws since they were first implemented. The goal of these programs is to ensure that injured workers have all their medical fees paid, usually directly to the provider of health care. Secondly, workers who have absences due to a work-related injury will also receive cash benefits. By working with a good workers compensation lawyer, people can ensure that they will receive compensation as much as possible. Over the past three decades, the biggest increase in benefits has been created by medical benefits. In 1984, these accounted for 33% of claims, and it is now around 50%, if not higher.

Exact changes do vary on a state by state basis. This is further reason as to why it is so important to work together with a very good workmans comp lawyer, mainly since all states showed a significant rise in how much they offered in benefits.

The report that has been created is a yearly publication. It is often seen as the bible for a workmans comp lawyer, as it allows them to predict not just the outcome of their case, but also how much they can expect their clients to earn in compensation.
