One of their notable legal cases is the 5-million dollar verdict for an airplane crash case in Broward County, FL, which caused the death of all four passengers including the pilot. The case was tried based on the Death on High Seas Act (DOHSA), which requires that only loss of companionship damages may be given to the survivor instead of the usual pain and suffering damages awarded under the Florida Wrongful Death Act. The firm brought he case to trial after the insurance firm of the defendant refused to pay even just one-fourth of the one-million dollar policy of the defendant. They were able to get a verdict that awarded their client \$5 million, which was 20 times the amount they had previously demanded from the insurance firm.

In another notable legal case, Peter Dyson succeeded in resolving a life insurance lawsuit that was tried in the federal court, obtaining a confidential settlement for the benefit of the family of an elderly man who died from cancer shortly after buying a life insurance policy. The insurance firm refused to pay the family?s claim for the life insurance policy because of the insured?s failure to disclose that he was diagnosed with cancer when he was applying for the policy. The insurance company also claimed that the deceased person had engaged in an illegal transaction that would have voided the insurance policy. However, Peter Dyson was able to find an inter-office email sent by the insurance firm that advanced the effective date of the decedent?s insurance policy in such a way that it was before the decedent was diagnosed with cancer. With that discovery, a large settlement was awarded to the family of the decedent.
