Furthermore, the government has several prosecutors for each case file, plus several victim advocates and other court staff lobbying to convince the judge to apply the harshest penalties. For those who are charged with any felony level criminal sexual conduct offense, and are convicted of any crime that is not even related to the original offense, the law mandates that the person

register as a criminal sexual and predatory offender. Thus, it is vital to hire a criminal sexual conduct attorney, such as Ryan Garry LLC, MN Criminal Lawyers, as quickly as possible.

First degree criminal sexual conduct involves sexual penetration or certain sexual contact with the victim under 13 years old. It carries a maximum penalty of 30 years in prison and/or up to a \$40,000 fine. Second degree criminal sexual conduct involves sexual contact and carries a maximum penalty of 25 years in prison and/or up to a \$35,000 fine. Third degree criminal sexual conduct involves sexual penetration, and the offender knows the other person is physically helpless or mentally impaired, the offender was a masseuse to the other, or the two have psychotherapist-patient relationship. It carries a maximum penalty of 15 years in prison and/or up to \$30,000 fine.

Fourth degree sexual conduct is sexual contact with another person similar to some other circumstance like those in third degree sexual conduct. It carries a maximum of 10 years in prison and/or up to \$20,000 fine. Fifth degree criminal sexual conduct is non-consensual sexual contact or certain acts of displaying the genitals to an individual under 16 years old. It carries a maximum penalty of one year in prison and/or up to a \$3,000 fine. However, the offense may become a felony if a second offense of exhibition of genitals to a person under 16 years old or the same offense in a different state.

Meanwhile, everything that is related to child pornography is illegal. Possessing or disseminating it if one is aware or should know what it is, are felonies. Dissemination of child pornography carries a penalty of up to 7 years in prison and/or up to a \$10,00 fine. Possession of child pornography carries a penalty of up to 5 years in prison and/or up to \$5,000 fine.
