Drug offenses are determined by the particular type of drug and the quantity. There are five degrees of drug offenses and all are classified as felonies. Each offense level has several possibilities and it is always a good idea to contact a drug lawyer in Minneapolis when faced with drug charges.

The first degree drug offense has to do with the selling of mixtures of at least 10 grams of heroin, cocaine, or meth or at least 50 grams of mixtures containing narcotic other than meth, heroin, or cocaine at least once within 90 days. The sentence is up to 30 years imprisonment and/or up to \$1 million fine. For those who have a prior conviction of this crime, the sentence is a minimum of four years up to a maximum of 40 years imprisonment.

The second degree drug offense involves the selling of mixtures of at least three grams of cocaine, meth, or heroin, or least 10 grams of mixtures containing a narcotic other than cocaine, meth, or heroin at least once within 90 days. The sentence can go as high as 25 years imprisonment and/or up to \$500,000 fine. If there is a prior conviction of this crime, sentence is a minimum of three years and a maximum of 40 years imprisonment.

The third degree drug offense involves selling at least one mixture of a narcotic drug or at least one mixture at least five kgs of marijuana within 90 days. It also involves possessing at least one mixture or at least 10 grams mixtures containing a narcotic other than heroin, cocaine, or meth at least once within 90 days. The penalty is up to 20 years imprisonment and/or a fine of up to \$250,000. If there is a prior conviction of this crime, the sentence is a minimum of two years and a maximum of 30 years imprisonment.
