Those who are well enough will have to do several things at the scene of the accident. First of all, it is a good idea to take pictures of the scene of the accident, including the cars and injuries. Second, it is also advisable to get the contact information of any witnesses who have seen the accident. Third, it is a good idea to look around for any surveillance cameras that might have a record of what happened. If the cameras are owned by private businesses, it is advisable to take note of the business and their contact number. Fourth, it is important to call the police to have a police report of the accident. Lastly, one should seek to inform the insurance company regarding the accident, but not before consulting with several personal injury attorneys who can offer advice on how to deal with the insurance company.

A spokesperson for Arrowhead Clinic Chiropractor Atlanta says, "If you don't have to be taken to the ER after your accident, you should still schedule an appointment with a car accident doctor as soon as possible. You will need to be examined by a medical professional, so you can be sure you don't have any serious underlying issues like whiplash or traumatic brain injuries. Linking any injuries after a motor vehicle accident will also strengthen the validity of accident claims."

Before filing a formal accident claim, it is important to consult with a personal injury lawyer, who can offer guidance. With the help of this attorney, the accident victim can file a formal claim. It is also possible to file a claim with one's own insurance company to get more benefits such as potentially underinsured motorist coverage, medical payments benefits, and additional coverages.

Several types of damages may be recovered through a settlement. The most frequent type of damage is for the medical bills. These include emergency treatment, imaging services, transport to the hospital, surgery, hospitalization, prescription medication, chiropractic care, rehabilitation, and follow-up care. Lost wages can be claimed if the injuries prevented the accident victim from working because of the required treatment. Loss of future earning capacity or business opportunities may also be claimed if the injuries have caused the accident victim to be unable to do the same type of work before the accident. The settlement will also cover the repair or replacement expenses for the motor vehicle, including the cost of renting a car while the vehicle is still unavailable. Physical and mental suffering may also be included in the settlement.

Meanwhile, if the injuries are not severe, the best doctor to consult with is an experienced car accident chiropractor. The chiropractor can also help with the personal injury claim by documenting all of the injuries suffered after the accident.
