Markhoff & Mittman, P.C. comments on a recent scandal involving the invalidation of approximately 17,000 Site Safety Training (SST) cards, which has sent shockwaves through the city's construction sector. At the center of this scandal is Brooklyn-based Valor Consulting, a company authorized to provide safety training and issue Site Safety Training (SST) cards to construction workers. In late February 2024, senior

executives and employees of Valor were indicted in Manhattan Criminal Court on charges of selling SST cards to laborers without actually providing the required safety training.

The New York City Department of Buildings (DOB) had first become suspicious of Valor's practices in April 2023, when they noticed "major inconsistencies" in the company's training records. This led to an immediate suspension of Valor's ability to conduct trainings and issue new SST cards. However, the full extent of the fraud was not revealed until the recent indictment.
