



Attorneys Discuss Legal Options for Adult Survivors of Childhood Sexual Abuse in Pennsylvania

Ashley DiLiberto, Esq. - The Abuse Lawyer PA is hosting an upcoming informational session to educate adult survivors of childhood sexual abuse about their legal rights and options in Pennsylvania. This event will address the current legal landscape and highlight potential legislative changes that could significantly impact survivors' ability to seek justice. The session aims to empower survivors with knowledge and resources to navigate the legal system effectively.

"Many adult survivors of childhood sexual abuse in Pennsylvania are unaware of their legal options," said Ashley DiLiberto, Esq. Under existing Pennsylvania law, survivors of childhood sexual abuse can file civil lawsuits against their abusers up to the age of 55. However, new legislative efforts propose removing the statute of limitations entirely, potentially opening a two-year "lookback window" during which survivors could file claims regardless

of when the abuse occurred. This development could be life-changing for survivors who were previously barred from seeking justice due to legal time constraints.

The informational session will cover several key topics, including current legal options for adult survivors under Pennsylvania law, proposed legislation and its potential impact on survivors' rights, the concept of "delayed disclosure" and its relevance to the statute of limitations reform, and resources available to survivors, including counseling and support services.

DiLiberto emphasized the importance of understanding these issues: "Many survivors do not come forward until later in life. Our laws must reflect the reality of how trauma affects disclosure timelines. Providing survivors with information and legal guidance is a crucial part of ensuring they receive the justice they deserve."

The event will also feature representatives from respected local support organizations, including WOAR Philadelphia Center Against Sexual Violence, which provides crisis support, counseling, and trauma therapy services, and the Philadelphia Sexual Assault Response Center (PSARC), which offers forensic examinations and medical care for sexual assault survivors in Pennsylvania in a professional, trauma-informed setting.

"While we focus on the legal aspects, it's equally important that survivors know about the support services available to them," DiLiberto added. "Healing is a multifaceted process, and we want to ensure survivors have access to all the resources they need, both legal and emotional."

The date and time of the informational session will be determined at a later date, and updates will be available on the firm's website.
