over substantial sums for materials and labor that were never delivered. "They left our yard in disarray, kept asking for more money for roof replacement materials, and then vanished. They were impersonating another company, but the details were just similar enough to deceive my dad."

This incident is not isolated. Even well-established companies like Tonys Roofing have faced the fallout from these schemes. Recently, Tonys Roofing was confronted with the startling reality that fraudsters were circulating counterfeit business cards, closely mirroring legitimate services. "We were shocked when we first heard about it. It's like something out of a crime drama," stated Erick, a representative from Tonys Roofing. These fake cards included nearly accurate business details but featured manipulated contact information, leading to confusion among potential clients. "We take it personally that this impersonation is happening all around us. We've never heard of them, let alone seen this level of activity previously," Erick emphasized. The discovery of a fraudulent website further compounded the issue, mirroring legitimate roofing company websites yet steering business towards scammers. "This has to end. Roofing companies dedicate their entire careers to building a reputable business, and we won't let scammers tarnish that legacy for our local communities," he declared with resolve.

Despite attempts to contact the provided fraudulent numbers and addresses, they had no response. The Better Business Bureau (BBB) for the West Coast & Pacific region has noted that such scams are unfortunately common within the roofing sector. These scammers often operate without proper licensing, bonding, or insurance, explained a media engagement manager from the BBB. Many victims, seeking justice, file police reports, but investigations often stall due to a lack of tangible evidence. The BBB strongly advises homeowners to be particularly cautious, especially with unsolicited door-to-door contractors. Verification and due diligence are key in preventing such financial losses.

The Portland Police Bureau has been proactive in their response, encouraging victims to report incidents either online or via their non-emergency line at 503-823-3333. Detective work often involves accessing the FTC Fraud Complaint database, aiming to connect patterns and apprehend culprits. Vigilance and reporting are crucial in combating these scams, according to the Portland Police Bureau, highlighting the investigative challenges and the community's role in resolution.

This situation underscores not only the financial toll on victims but also the vigilance required by established businesses to maintain community trust.
