The first of the new communities, Riverwood Meadows, will be situated in northwest Winnipeg and will encompass approximately 280 acres of carefully planned residential space. The development will feature a mix of single-family homes, townhouses, and multi-family dwellings designed to accommodate various lifestyles and budgets. A significant portion of the land has been dedicated to green spaces, including a central park, walking trails, and natural wetland preservation areas that will serve as both recreational amenities and important ecological habitats.

In southeast Winnipeg, Ladco is introducing Prairie Vista, a 320-acre community that will incorporate the latest thinking in neighborhood design. The development will feature a village-style town center with

small-scale retail and service amenities within walking distance of residential areas. Transportation planning will emphasize connectivity, with dedicated cycling paths and pedestrian walkways integrated throughout the community. The third development, Aspen Ridge, located in southwest Winnipeg, will transform 210 acres into a community that pays homage to Manitoba's natural landscape. The development will preserve existing stands of aspen trees and incorporate native prairie plantings throughout public spaces. Home designs will emphasize energy efficiency and sustainable materials, reflecting growing consumer demand for environmentally responsible living options. Community facilities will include public gathering spaces, recreational facilities, and areas designed specifically to encourage outdoor activity throughout Winnipeg's four seasons.

Collectively, these three new communities Winnipeg will add approximately 3,800 new homes to Winnipeg's housing inventory over the next decade, helping to address housing needs while creating vibrant neighborhoods that reflect Ladco's philosophy of community-minded development.

Energy efficiency will be encouraged through lot orientation that maximizes solar exposure and community guidelines that promote sustainable building practices. Natural habitat corridors will be preserved to support urban wildlife and enhance biodiversity within the city's new communities Winnipeg.
