

## Woman Seeks To Pursue E-Cig Explosion Lawsuit After Allegedly Suffering A Broken Jaw, Teeth, And Facial Burns

She indicates that although her teeth look substantially improved from the ?mangled mess? she first came in with, ?...they don?t feel great. At all.? The dentist working on her indicated that he had never seen damage like what she had suffered when she first came in and reported that this included a broken upper jaw bone, broken teeth, and burns. The woman reports that she is working with an attorney to file a lawsuit and that she is unsure how to

put a price on what she feels that she has lost.

Unfortunately, many others join her in alleging that they too have suffered after experiencing an e-cigarette

explosion. An Olive Garden Employee recently made news when his e-cigarette reportedly exploded in his

pocket, burning his body significantly. As e-cigarette use becomes increasingly popular, many feel that these

incidents will happen with increasing frequency as well.
