



## **Siam Legal Explains Legal Risk From Public Disputes for Foreigners**

Siam Legal International, a full-service law firm with more than 22 years of experience assisting foreign nationals in Thailand, is noting increased public attention to how minor public disputes can carry criminal consequences, following a widely viewed incident on Bangkok's BTS Skytrain involving a group of foreign students.

The incident occurred on July 23, 2026, when a Thai passenger asked a group of foreign youths to lower their voices on the Silom Line near Sala Daeng station. The exchange escalated into insults and an obscene gesture, and the video was later viewed by millions of people online. Police fined five members of the group 1,000 baht each for insulting another person in their presence, and one member received an additional 1,000 baht fine for committing an indecent act in public.

The case was resolved after the group formally apologized at a police station and paid the fines, with both sides agreeing not to pursue further legal action. Siam Legal International notes that this outcome illustrates how quickly a public dispute can move from an informal disagreement into a documented criminal matter under Thai law.

Under Thai criminal law, two categories are most relevant to everyday public conduct. The first covers minor public offenses, sometimes described as misdemeanors, which include acts such as public insults, aggressive behavior, threats, or causing embarrassment in front of others. These offenses do not require physical harm and can still result in fines or short-term detention. The second is defamation, which applies when spoken, written, or posted statements damage another person's reputation. When defamatory content is distributed publicly, including through social media, penalties can increase and may include imprisonment.

Rex Baay, Operations Manager at Siam Legal International, said the threshold for criminal exposure in Thailand differs from what many long-term residents and visitors expect. "A person does not need to raise a hand to face criminal liability in Thailand," Baay said. "An insulting word or a single gesture, if it is seen as offensive or humiliating, can be enough to support a complaint, and whether that complaint proceeds often depends on whether the other person feels harmed."

Siam Legal International also points to the growing role of video and social media in these cases. Because public spaces in Thailand are now routinely recorded, a short clip can become evidence in a criminal complaint, and reposting or sharing that footage can create separate legal exposure under defamation provisions. What begins as a brief altercation can therefore develop into a formally documented case well after the original moment has passed.

The firm suggests that foreign residents and visitors take a cautious approach to public disagreements. This includes avoiding insulting gestures or language in shared spaces, declining to escalate arguments with strangers, and refraining from comments that target a person's nationality, identity, or appearance. Individuals should also be mindful when posting or sharing footage that names or shows other people, since such content can later be treated as evidence.

Siam Legal International states that this guidance is particularly relevant for long-term residents and others who interact regularly with the public, including in transit systems, markets, and other shared spaces.
