The two have directed the practice together since the mid-1990s.

The team includes Dr. Dan McClellan, who has practiced for 32 years, along with Dr. Joshua Taylor, Dr. Clayton Koon, and Dr. Alex Randolph. These practitioners support both clinical care and outreach activities such as the Northwestern Mutual visit.

The clinic's services focus on chiropractic care for conditions including back pain, neck pain, headaches, shoulder pain, carpal tunnel syndrome, sciatica, and disc injuries, as well as general wellness. Family-oriented care is also available. Outreach events complement office-based services by bringing brief wellness sessions into professional environments.

Workplace visits such as the one with Northwestern Mutual allow the practice to interact with local professional teams. Chair massage sessions provide a practical demonstration of relaxation techniques in a non-clinical setting. The Gadsden Northwestern Mutual office, located at 715 Walnut Street, is among the nearby businesses the clinic has engaged.

Dr. Mike McClellan, clinic director, stated, "Workplace events provide an opportunity to share basic principles of spinal health and relaxation with teams in their own professional environments."

Dr. Leslie McClellan, clinic director, stated, "Connecting with local businesses through short wellness sessions supports the clinic's focus on community engagement."

Chiropractic practitioners complete undergraduate studies followed by professional training at a chiropractic college. The educational process includes classroom instruction and supervised clinical experience. McClellan Family Chiropractic applies this training in both patient care and community activities.

The Northwestern Mutual event forms one example of the clinic's ongoing outreach. Similar sessions have been held for other local groups, including educational and medical workplaces. These efforts remain centered on practical, accessible wellness experiences.

McClellan Family Chiropractic continues to participate in community initiatives while maintaining its clinical focus in Rainbow City. The practice combines hands-on chiropractic methods with lifestyle guidance drawn from The 100 Year Lifestyle framework.

The full team contributes to both patient care and external events. This structure supports continuity in the office and participation in local workplace activities. The August visit with Northwestern Mutual illustrates the clinic's engagement with area professional teams.
