



Mogy Law NC Announces 25 Percent Contingency Fee Policy

RALEIGH, NC - August 17, 2026 -

Eric Mogy, founding attorney of Mogy Law and a member of the North Carolina Bar since 2013, has announced a firmwide policy of representing personal injury clients in Raleigh and Wake County at a flat 25 percent contingency fee. The policy sets the firm's fee below the 33 percent contingency rate that many North Carolina personal injury firms apply, a difference the firm states leaves a larger share of any recovery with the client.

Contingency fees determine the portion of a settlement or verdict that a law firm retains as payment. Under the firm's policy, clients recovering compensation from car accidents, truck crashes, and motorcycle injuries are charged a fixed 25 percent rather than a higher percentage. As a 25% lawyer Raleigh clients can retain, the firm structures each case so that the specific dollar effect of that difference varies with the size of the matter, while litigation costs and case expenses are addressed separately from the contingency percentage.

Eric Mogy has been recognized by Super Lawyers Rising Stars, a designation extended to no more than 2.5

percent of licensed North Carolina attorneys each year through a peer-influenced, research-driven evaluation. He has also been named to the National Trial Lawyers Top 40 Under 40, a performance-based recognition that assesses trial skills, results, and professional standing among younger personal injury practitioners.

The firm's documented prior results include a 1.2 million dollar car accident verdict, an 860,000 dollar tractor-trailer settlement, a 615,000 dollar car accident settlement, and a 485,000 dollar commercial accident settlement. These outcomes reflect past cases and do not guarantee similar results in any future matter. The record spans both negotiated resolutions and courtroom verdicts across the North Carolina personal injury process.

Eric Mogy earned his law degree from the University of Tennessee College of Law, and partner Chris Anglin adds further courtroom experience to the firm's Raleigh practice. Together they provide Wake County clients with a two-attorney team operating under the firm's 25 percent fee policy.

"The difference between 25 percent and 33 percent reflects a choice between charging what the market allows and charging what the work actually costs," said Eric Mogy, Founding Attorney at Mogy Law. "Peer recognition through Super Lawyers and the National Trial Lawyers reflects the same principle, which is earning what is charged rather than charging what one can. Raleigh's growing Spanish-speaking community faces the same challenges as any other Wake County resident after an accident, and bilingual service ensures those clients receive the same fee structure and the same quality of representation."

The firm delivers counsel in both English and Spanish, extending the same fee policy to every client regardless of language. Additional attorney background is available through the Mogy Law NC 25% lawyer profile on their website.
