



## **Mogy Law TN Announces 25% Fee for Tennessee Clients**

accident to file a claim ? the shortest filing deadline of any civil remedy under state law. That compressed timeline makes prompt consultation with a Nashville or Memphis personal injury attorney the most time-sensitive step available to an injured victim in either city.

Tennessee also follows a modified comparative fault standard with a 49% bar. An injury victim found 49% or less at fault may still recover damages, reduced proportionally by their assigned percentage of fault, while a victim found 50% or more at fault recovers nothing. That standard gives Tennessee accident victims recovery options but still requires experienced representation to prevent insurers from pushing fault percentages above the threshold. As an Eric Mogy 25% lawyer Tennessee resource, the firm emphasizes early case investigation to document fault accurately from the outset.

"The one-year statute of limitations is the deadline that costs Tennessee injury victims the most," said Eric Mogy, Founding Attorney at Mogy Law TN. "Nashville and Memphis accident victims who wait often find they have already passed the filing window by the time they realize their injuries require long-term treatment. The 25% fee is not a marketing number. By keeping overhead lower and staying personally focused on each case, a smaller firm can charge less than the 33% to 40% that larger firms charge while also delivering trial-ready representation. Serving clients in both English and Spanish is a part of how the firm operates, not a tagline."

The firm provides bilingual English and Spanish representation, including dedicated Spanish-speaking staff, ensuring that Tennessee's growing Spanish-speaking communities have access to the same quality of advocacy and the same 25% flat fee that English-speaking clients receive.
