



Great Falls FCU Highlights Accessible Savings Options

Great Falls Federal Credit Union is announcing a renewed focus on accessible savings options for consumers in the Lewiston-Auburn community, highlighting a savings account in Auburn, ME designed to give members a straightforward way to set money aside, earn interest, and manage funds through convenient banking channels. The announcement reflects the credit union's ongoing commitment to providing practical financial services to the communities it serves.

Great Falls FCU's savings offering is structured around simplicity and accessibility. Members can open an account with a minimum deposit of \$25 and earn interest on their balance. The account is intended to support a range of financial goals, from creating a reserve for unexpected expenses to saving for a planned purchase or building funds for the future.

Great Falls FCU states that its savings accounts are federally insured and that the credit union uses security measures to protect members' personal and financial information. The savings announcement comes as the credit union continues to make its financial services more visible to members and prospective members. By drawing attention to an account with a modest opening requirement, access methods, and an emphasis on transparency, Great Falls FCU is presenting savings as a part of financial planning rather than a complicated process. The information gives consumers an opportunity to review a savings option and consider whether it fits goals.

The announcement also connects the savings offering to Great Falls FCU's longstanding presence in the area. The credit union was founded in 1955 by workers from Knapp Shoe and became the first "industrial credit union" in Lewiston-Auburn. Its original purpose was rooted in building a lasting financial institution for the community, a mission the organization says continues to shape its work today.

Great Falls FCU's growth has included partnerships and organizational changes that have expanded its presence. In 1996, it merged with New Auburn Credit Union, formerly St. Louis Federal Credit Union. In 2022, Monmouth Federal Credit Union joined Great Falls FCU, further expanding the organization's ability to provide financial services and support to members.

For people interested in opening an account, Great Falls FCU provides a direct process through its branches or website. Applicants can provide valid identification and other required documentation before making the initial \$25 deposit. The process gives prospective members a clear starting point for putting money aside and working toward individual financial objectives.
