His early work contributed to standards and practices that Colorado family law courts and practitioners would come to rely on in the decades that followed. Today, the firm he founded continues to operate as a multi-generational practice, with his sons Robert T. Hinds III and Michael P. Hinds serving as shareholders alongside a team of attorneys, paralegals, and legal staff.

The firm's attorney team also includes C. Darin Jensen, Monica M. Colvig, and Brianne M. Henninger, along with historical of Counsel roles being filled on by well-known Family Law attorney Frank L. McGuane Jr. Paralegal and administrative support is provided by Laurel Ayers, Kendall P. Hartman and Jordan McBride. This structure allows the firm to handle a broad caseload while maintaining the direct attorney involvement

that has been part of its practice model since its founding.

The firm provides legal counsel across the full spectrum of family law matters, including divorce and legal separation, mediation services, custody and parenting time, child support, property division, spousal maintenance, prenuptial and postnuptial agreements, step-parent adoption, grandparents' rights, protective orders, mediation and alternative dispute resolution, post-decree modifications, and appeals. The firm also handles LGBTQ+ family law representation and interstate custody matters governed by the Uniform Child Custody Jurisdiction and Enforcement Act and the Parental Kidnapping Prevention Act, areas that require specialized knowledge of multi-jurisdictional legal frameworks not offered by every family law practice in the state.

Hinds and Hinds Family Law has received recognition from five independent legal rating platforms, including Best Lawyers in America, Super Lawyers, Martindale-Hubbell at its highest rating, and Avvo. The firm holds membership in the American Academy of Matrimonial Lawyers, the International Academy of Family Lawyers, and the Association of Family and Conciliation Courts, professional bodies that recognize attorneys with sustained focus on matrimonial and family law practice.

The firm's approach to family law has centered on the well-being of children throughout divorce and separation proceedings, with an emphasis on personalized attention to each client's circumstances. That approach, established at the firm's founding, has shaped the practice's growth over more than four decades and its role in the evolution of family law in Colorado.

"Forty-six years is a long time to stay committed to one area of law, but that commitment has always been the point," said Michael P. Hinds, Managing Shareholder at Hinds and Hinds Family Law. "Our father set a standard for putting families and children first, and every attorney who has joined this firm since has carried that forward."

The firm operates out of its Greenwood Village office in the Denver metropolitan area and serves clients across all of Colorado through both in-person and video consultations. New clients typically begin with an initial paid consultation, during which an attorney reviews the case and outlines the legal options available before any representation begins. As it marks this anniversary, the practice continues to serve Colorado families with the child-first advocacy and relationship-driven legal counsel that has defined it since February 1980.
