



Chin Up! Aesthetics Details Full-Time Provider Staffing Model for Metro Atlanta Medical Spa Operations

Atlanta, Georgia - August 31, 2026 -

At Chin Up! Aesthetics, all treatments across its three Atlanta-area locations are performed by full-time employed providers. The practice describes this as a departure from the part-time rotation arrangements it has observed elsewhere in medical aesthetics. The staffing approach is intended to support treatment continuity for patients receiving multi-session aesthetic protocols at the company's Kennesaw, Decatur, and Smyrna/Vinings facilities.

According to Chin Up! Aesthetics, rotating and part-time injector arrangements are used by a number of medical spa operations, and patients treated under those arrangements can see different providers from one visit to the next. The practice cites scheduling flexibility and lower operating overhead as reasons other operators adopt the model. The company presents this as its own observation of the field rather than a measured industry statistic, and it has not published data comparing the two arrangements.

Under the practice's own policy, one provider oversees a patient's multi-session plan from the initial

assessment onward. The practice's clinical leadership has said the arrangement lets the same clinician compare a patient's progress against the baseline recorded at the first visit. Chin Up! Aesthetics presents this as an operating preference. It does not cite clinical research in support of it, and individual results vary. Treatment recommendations are made case by case following consultation.

"When a patient commits to a series of treatments, having the same provider evaluate their progress at each session means we're building on the previous work rather than starting fresh each time," said Afsha Hussaini, Lead Nurse Practitioner and Co-Owner of Chin Up! Aesthetics. "This continuity matters for treatments like Sculptra or dermal filler series where we're monitoring how a patient responds over months. We can refine our approach at each visit because we have the full history with each patient."

The practice employs nurse practitioners, physician assistants, and licensed medical aestheticians across its three locations. All providers hold the state licensing and certification required for their respective roles. Chin Up! Aesthetics states that full-time employment is intended to give providers time to develop depth in specific treatment modalities and to maintain detailed patient records.

The full-time employment model connects to the company's internal training program, which provides ongoing instruction to staff. The practice reports that this approach is designed to keep treatment standards consistent regardless of which location patients visit within the network. Instruction covers injection technique, patient assessment, and complication management.

"We prioritize hiring providers who want to build their career in aesthetics rather than rotating through multiple practices," said Hussaini. "This allows us to invest in training and means our patients receive care from providers whose primary focus is aesthetic medicine. Our providers aren't splitting their attention between multiple specialties or locations."

The practice offers complimentary consultations and extended evening hours on Tuesdays and Thursdays. Chin Up! Aesthetics states that these scheduling options are intended to help patients keep appointments with the same provider throughout a treatment course.

Hussaini holds credentials that include service as a national trainer for Galderma and a fellowship in Plastic Surgery from the Cleveland Clinic. The company operates locations in Kennesaw at 2914 Cherokee Street NW, Decatur at 2786 N Decatur Road, and Smyrna/Vinings at 2255 Cumberland Parkway SE.

Under the same structure, a patient's plan remains with one provider for its duration. Patients considering any aesthetic treatment are advised to discuss risks, benefits, and expected outcomes with a licensed provider during consultation.
