The e-service mandate changes how legal documents are exchanged among parties in civil matters, requiring attorneys to serve filings electronically rather than through traditional methods. By aligning its internal systems with the new procedural rules in advance, the firm aims to reduce delays for clients pursuing compensation after serious accidents.
