



Weinstein Firm Announces \$300K Liberty Mutual Win

The Weinstein Firm has resolved a Georgia motor vehicle accident claim through a negotiated result with one of the nation's largest liability insurers. The Weinstein Firm negotiated a \$300,000 settlement with Liberty Mutual on behalf of a client injured in a crash, a result achieved through claim preparation that included investigation of the crash circumstances, documentation of the client's damages, and negotiation based on the available evidence rather than simply presenting a demand equal to the client's medical bills.

The outcome reflects how personal injury negotiations are actually evaluated and resolved in Georgia. Adding up medical expenses represents only one part of the analysis. The facts surrounding responsibility for the incident, the nature and duration of the injuries, treatment records, lost earnings, future limitations, and other evidence can all affect how a claim is valued by an insurance carrier such as Liberty Mutual, making thorough documentation the foundation of effective negotiation.

Georgia's comparative fault rules further shaped the evidence strategy. Those rules allow a victim to recover damages so long as they are found less than 50 percent at fault, and the percentage of fault assigned to each party directly determines the percentage of damages recoverable. That framework makes liability

evidence especially important when responsibility for a crash is disputed. In this matter, photographs, witness statements, crash evidence, medical documentation, and a clear timeline of the incident formed the evidentiary basis for the settlement.

Context matters because of who sits across the negotiating table. Liberty Mutual, one of the largest personal injury liability insurers in the United States, employs professional claims adjusters and legal teams experienced at evaluating and minimizing personal injury settlement values. That environment makes the quality of a claimant's evidentiary preparation and legal representation a direct factor in whether negotiations produce a meaningful result or a lowball offer.

"Liberty Mutual is a sophisticated insurer with experienced adjusters who evaluate claims based on the strength of the evidence, not on the size of the demand letter," said Harris Weinstein, Managing Partner of The Weinstein Firm. "This \$300,000 result came from building the record that supported it, from the crash investigation and the medical documentation to the lost earnings calculation and the comparative fault analysis that established the client's position. Whether a client was injured in Decatur, Sandy Springs, or anywhere else in Metro Atlanta, that same evidence-first preparation determines whether a negotiation produces a meaningful result."

The negotiated result reflects the value of investigating the circumstances of an incident early, documenting injuries through consistent medical treatment, preserving crash-scene evidence, and building a complete picture of a client's economic and non-economic losses before presenting a settlement demand. That is the same approach The Weinstein Firm applies to every Georgia motor vehicle accident claim it handles.
