Lawyers cannot nominate themselves, and the selections are made annually, state by state. Selection to a

"Truck and commercial vehicle cases often involve federal regulations, corporate defendants, and complex questions of liability," Flanagan said. "Preparing those matters thoroughly, from the initial crash report through the courtroom, is central to how the firm approaches its work across Georgia."

The firm has been involved in significant matters, including a \$99.9 million truck accident verdict and the resolution of a commercial truck accident case for \$2.5 million. Its practice areas include car accidents, truck accidents, bus accidents, motorcycle accidents, rideshare accidents, premises liability, dog bite claims, wrongful death, and catastrophic injury cases.
