The company reports that most title applications are processed within 48 to 72 hours after complete and correct documents are received. A priority processing option is also available for time-sensitive matters. Greenlight Titles does not require a monthly minimum transaction volume, which allows lienholders and other clients to use the service according to their own needs rather than a fixed schedule.

"Timing matters a great deal in this field, particularly when a repossession is involved and a title correction stands in the way of resale," Gran said. "The goal of the expanded service is to keep those files moving so lienholders are not left waiting on paperwork that affects their bottom line."

The expanded lienholder focus complements the other services the company provides. Greenlight Titles works with auto dealerships on out-of-state title transfers and registrations, assists corporate fleets with registrations and renewals in all 50 states, and offers an Oregon DMV walk-in service for tag agencies that need plates processed over the counter within 24 to 72 hours.
