MADD or Mothers Against Drunk Driving estimates that there are approximately 40,000 arrests in the state for driving under the influence each year, which is a substantial percentage of the total accidents annually. Atty. Gross says that this is unacceptable.

"The cost of medical bills alone can be staggering for victims of a DUI," the attorney states. "You're looking at ambulance costs, as well as hospital and doctor fees, and in severe cases, your family may be facing funeral costs. It's completely insane to expect a victim or his or her family to pay for all of this."

Atty. Gross says that in addition to monetary costs, there are physical and mental issues to consider. Many drivers are fearful of even riding in a vehicle after such an accident. Some face exorbitant auto repair costs and others miss work due to physical impairments after an accident.
