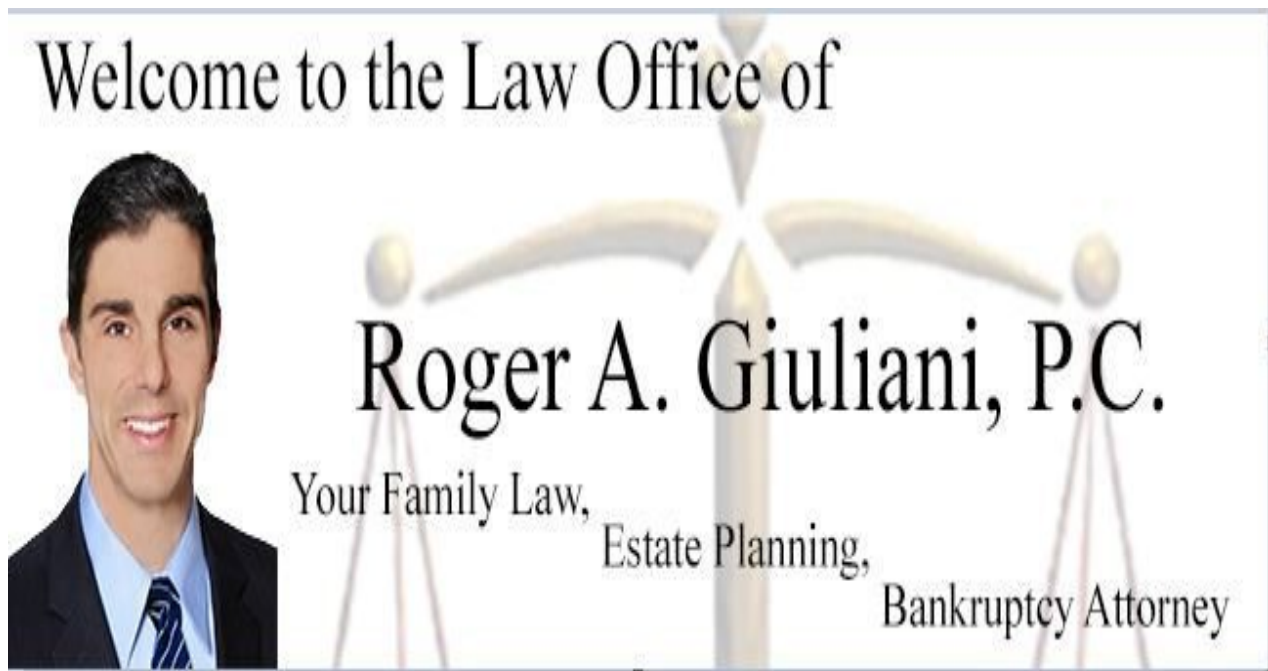




Las Vegas Probate Lawyer Opens New Henderson Office

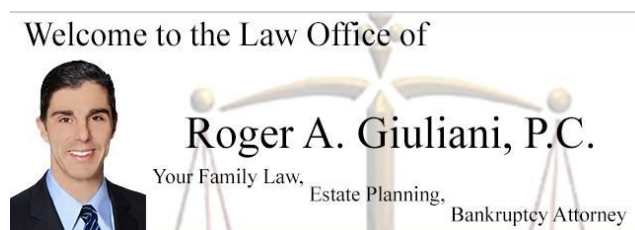
