It was recently announced that AmeriHealth 65 HMO will be discontinued starting in 2017 for seniors in New Jersey. Aetna's Medicare Value Plan will also no longer be available which will leave many seniors scrambling to replace their lost coverage.

This may result in a crisis as almost 20,000 seniors in New Jersey are suddenly in a position where they could be placed on Original Medicare starting January 1st, 2017. This change can leave many with very large hospital deductibles, as well as responsibility for 20% of all medical costs. It could also result in a discontinuation of prescription drug coverage.
